Fol pers (Race-W), AC, Are reld asgmt & dy orgns indicated, will be ret to continental US as casuals for purpose of recuperation under prov of par 1, Sec III, WD Cir 372, 13 Sep 45, WP o/a 26 Oct 45, fr present overseas sta to a US port. Pers are moving under SUNSET PROJECT, not for Sepa ration, except as indicated. Upon arr at a US Airport, pers will be moved by and under control of CG, ATC, to Camp Stoneman, Calif, for further movement to appropriate Separation Ctr. Tvl dir will be performed by orgn mil acft to continental US, as designated by Opns O, and by GMT, rail or such other means of T as may be avail, fr sta at which debarked, to Camp Stoneman. Pers records and allied papers will be forwarded in accordance with par 33, WD RR 1-2, except that extra cy of WDAGO Form 66-2, will not be forwarded to TAG, but will accompany C concerned. Pers will be processed by their respective orgns before departing this sta. Crew members will retain in their possession and take with them all equip currently auth and entered on their Form 121. Any equip not considered essential for purp of this movement may be turned in and deleted fr Form 121. Pers will notify correspondents & publishers to discontinue mailing of ltrs & publications until informed of new address. Indiv clothing & equip of pers will be handled in accord with Jtr, Hqs, 20AF, file AIAFS 420, subj: "Status of Indiv Clothing & Equip of Pers Ret to US", dd 17 Sep 45. Personal baggage will be strictly limited to (80) lbs for O's and (50) lbs for EM, and will be carefully insp by Comdr preparing movement.
